Approx. 150 partners active or relevant for road networks, covering 90%+ of the TERN 22 Member states


Supported by the Euroepan Commission

How does EasyWay work:

•Produce Revise and promote **Deployment Guidelines** according to Member State and stakeholder requirements

Deploy and monitor harmonised services across Europe according to agreed
Deployment Guidelines

•Develop cooperation with external stakeholders on Viability Studies, with the aim to set up new Deployment Guidelines, or supporting actions


EasyWay is structured into Euro-Regions, each concerned with cross-border issues below the pan-European Scale

ES 5 DATEX Started in 2008


New ESG 5 in charge of all aspects concerning DATEX and tasked as


